

## CTYSD07FB10 Chevy Tahoe / Yukon / Suburban / Denali (Loaded / Amplified)



Open second row cup holder and locate the (5) screws.





Pull gently on the second row audio and climate control panel to unclip it, unplug wires and set to the side for reassembly.



Remove the (5) screws and cup holder and set to the side for re-assembly.



Remove the (2) screws, remove rear trim panel and pop out wire retainers.

<u>Step 6</u>



Remove the (4) screws in bottom of storage area and set to the side for re-assembly.

Step 7

Step 5



Open storage area.

Move front seats all the way forward. From the second row seating area, locate the screws by the floor on the side of the counsel. There are screws on both sides of the counsel. Remove screws and set to the side for re-assembly.

- <u>Step 8</u>



Move seats all the way back, from the front seat area, locate the screws by the floor on both sides of the counsel. Remove and set to the side for re-assembly.

Step 9



Remove cup holder and tray by pulling up on the tray. Pop out wire retainers.



Place enclosure onto hump area under counsel as shown in photo.

<u>Step 13</u>



From the passenger side, locate the stud towards the front of vehicle and attach one of the supplied brackets with supplied hardware. Attach bracket to enclosure with screws so it will still go over factory stud.



Re-assemble counsel in reverse process, reusing all factory fasteners and enjoy, your installation is now complete.

## -<u>Step 10</u>-



Slide counsel to the back and tip upward to expose wires and area under counsel.





This shows how the enclosure should look.





Using remaining bracket and hardware, attach to enclosure as shown. Remove screw from floor and fasten enclosure to floor with this screw. Make final speaker connections.

MTX disclaims any liability for other incurred damages resulting from product defects. Any expense in the removal or reinstallation or products are not covered by this warranty. MTX's total liability will not exceed the purchase price of the product. If a defect is present, your authorized MTX dealer may be able to effect repairs.
